RE: **High Point (Cooper to Arbrook) Sanitary Sewer Renewals, Project No. WUOP16012**

Dear Arlington Water Utilities Customer:

In September, the Arlington City Council approved the execution of a construction contract with Ark Contracting Services, LLC, of Kennedale, for the High Point (Cooper to Arbrook) Sanitary Sewer Renewal. **Construction is scheduled to start Monday, Feb. 5, 2018.** The location map on the other side of this letter identifies the locations that will be directly affected by construction.

Affected property owners and tenants are invited to a public information meeting scheduled for 6-7 p.m., **Thursday, Jan. 25, 2018**, in the Council Briefing Room on the 3rd floor of City Hall, **101 W. Abram St, Arlington, 76010. A short presentation at 6 p.m.** will provide information about the construction activity and the project schedule. In addition, representatives from the City of Arlington and Ark Contracting will be available to answer questions you may have concerning the planned construction.

The following is additional information that may help answer questions you have:

- Construction is scheduled to begin on Monday, Feb. 5, 2018. The anticipated construction time is 300 calendar days.
- Project scope includes the renewal of public sanitary sewer mains. Sanitary sewer services will be replaced from the new city main to the property line or the easement line. All streets within the project limits will be repaved by street reclamation.
- Grass areas affected by construction will be restored by the contractor with sod or hydromulching to match the existing condition and will require watering by the property owner after being established. A City of Arlington construction inspector will videotape the project area to document existing conditions before the start of construction.
- Streets might be closed to through traffic during construction, but residents will be provided access to their properties. Parking in your driveway may be restricted at times during the installation of pipes and subsequent street reclamation. This will be coordinated with you by the contractor.

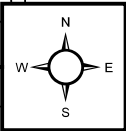
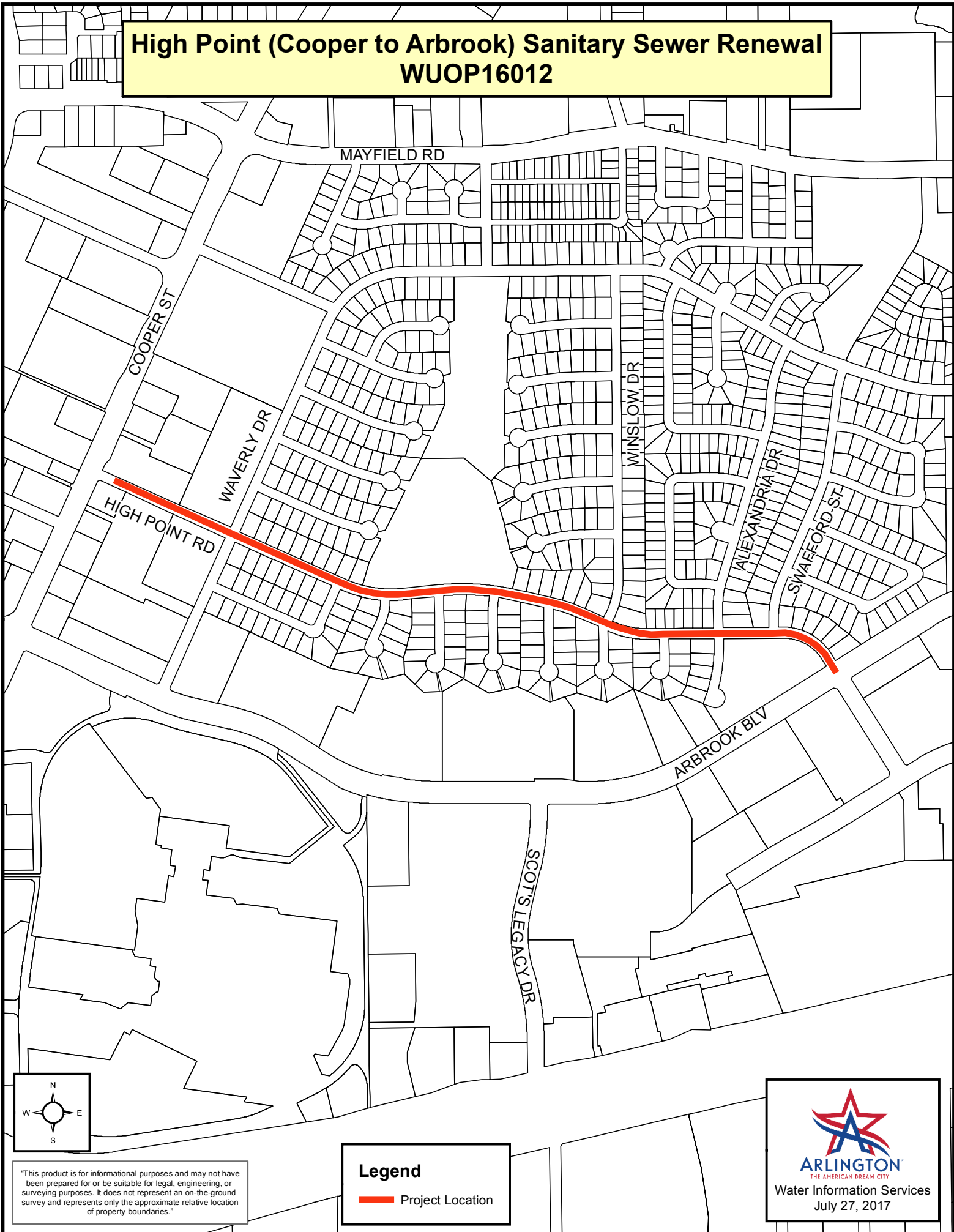
