Construction Contract for the Woodside Drive Sanitary Sewer Main Replacement, Project No. WUWS18016

City Council Meeting Date: 03-29-2022 Action Being Considered: Minute Order

#### RECOMMENDATION

Authorize the City Manager or his designee to execute a construction contract with Klutz Construction, LLC, of Kennedale, Texas, for the Woodside Drive Sanitary Sewer Main Replacement Project in an amount not to exceed \$1,379,444.01. Klutz Construction, LLC, is an MWBE firm.

## PRIOR BOARD OR COUNCIL ACTION

On June 25, 2019, City Council approved Minute Order No. 06252019-017 authorizing the execution of an engineering services contract with Stantec Consulting Services, Inc., of Dallas, Texas, for the analysis and evaluation of the Woodside Drive sanitary sewer main replacement, in an amount not to exceed \$400,000.

## <u>ANALYSIS</u>

In recent years, heavy rainfall events have caused extreme soil erosion around an 8-inch sanitary sewer main that crosses the Kee Branch creek near 3901 Woodside Drive. This erosion has caused exposure and failure of the sanitary sewer main which has resulted in emergency repairs.

This project replaces approximately 260 linear feet of 8-inch sanitary sewer main crossing the creek. As part of the overall erosion protection plan, the project also includes backfilling and regrading to stabilize the creek bottom and banks at the crossing area, planting trees, shrubs, and live staking, and construction of approximately 350 linear feet of rock cascades with boulders and micro-pools along the bottom of the creek. This project will extend the life of the public facilities, reduce maintenance costs, and improve service to these areas. These creek improvements have been designed in consultation with the Stormwater Division of Public Works.
