### RECOMMENDATION

Authorize the City Manager or his designee to execute an annual requirements contract for caustic soda with Petra Chemical Company, LLC, of Dallas, Texas, in the estimated amount of \$834,535. Petra Chemical Company, LLC, is not an MWBE firm.

#### **ANALYSIS**

This contract is for caustic soda which is a chemical that is used in the water treatment process. The caustic soda is used to adjust the pH (stability) of the water to ensure that it does not corrode distribution lines and home plumbing. Caustic soda will be provided on an as-needed basis.
