



Two-Year Annual Requirements Contract for Security Guard Services, Project 22-0143

City Council Meeting Date: 09-27-2022 Action Being Considered: Minute Order

RECOMMENDATION

Authorize the City Manager or his designee to execute a two-year annual requirements contract for security guard services with Vets Securing America of San Antonio, Texas, in the estimated amount of \$960,343. Vets Securing America is not an MWBE firm.

PRIOR BOARD OR COUNCIL ACTION

On April 26, 2022, City Council approved Resolution No. 22-085 authorizing the competitive sealed proposal procurement method for armed security guard services.

ANALYSIS

An RFP was issued to solicit responses from various firms experienced with providing security guard services for two buildings located at 101 South Mesquite Street (City Tower) and 101 West Abram Street (City Hall), Arlington Texas. Security guard services will include:

City Tower

Two (2) on-site uniformed armed security guards from 7:00 a.m. to 5:00 p.m. Monday thru Friday, excluding City holidays.

One (1) on-site uniformed armed security guard from 5:00 p.m. to 7:00 a.m. Monday thru Thursday.

One (1) on-site uniformed armed security guard from 5:00 p.m. Friday thru 7:00 a.m. Monday including City Holidays.

<u>City Hall</u>

One (1) on-site uniformed armed security guard from 4:30 p.m. to 8:00 a.m. Monday thru Thursday.

One (1) on-site uniformed armed security guard from 4:30 p.m. Friday thru 8:00 a.m. Monday including City Holidays

An evaluation team comprised of City staff evaluated and scored the submittals based on weighted criteria, operational plan, background, references and staff structure, and overall cost.

Office of Business Diversity recommended the citywide aspirational goal of 30% MWBE participation on this contract. Vets Securing America has opted to self-perform the project scope internally. OBD will assist the vendor with their efforts if any subcontracting opportunities become available.

#### FINANCIAL IMPACT

In accordance with Local Government Code 252.042, the bid was awarded based on request for proposals relative to overall score of operational plan, background, references and staff structure, and cost. Vets Securing America was awarded based on this criteria. The contract term is for two-years and will be reviewed annually to determine subsequent renewal terms.
