# Annual Requirements Contract for Fill Materials, Processed Cushion Sand and Washed Concrete Sand, Project 22-0147

#### **RECOMMENDATION**

Authorize the City Manager or his designee to execute an annual requirements contract for the purchase of fill materials, processed cushion sand, and washed concrete sand with Earth Haulers, Inc., of Fort Worth, Texas, in the estimated amount of \$457,235.

### **ANALYSIS**

This contract provides fill material and processed cushion sand and washed concrete sand for new construction projects, repair projects and for maintenance of various athletic fields throughout the City. The contract includes brick sand, topsoil, rock, clay and gravel. The contract also includes processed cushion sand and washed concrete sand used for construction and repair of water and sewer lines throughout the City. The fill material will be used by various departments and purchased on an as-needed basis.
