Annual Requirements Contract for Health and Fitness Assessments, Project 23-0156

RECOMMENDATION

Authorize the City Manager or his designee to execute an annual requirements contract for health and fitness assessments with Front Line Mobile Health, PLLC, of Georgetown, Texas, in the estimated amount of \$450,000. Front Line Mobile Health, PLLC is not a MWBE firm.

PRIOR BOARD OR COUNCIL ACTION

None.

ANALYSIS

This annual requirements contract is for a medical provider with in-depth knowledge regarding fire-service specific medical assessments in accordance with the National Fire Protection Association (NFPA) 1582 standards to provide consolidated medical assessment, possible immunizations, and data record-keeping services of all incumbent uniformed Fire personnel.

An evaluation team comprised of City staff from the Fire Department, Police Department, and The Office of Business Diversity evaluated and scored the submittals. A weighted criteria approach was used for scoring, which included operational planning, experience/qualifications and price. The following vendors were evaluated:
