Removal and Replacement of Lake Arlington Buoy System, Project 23-0159

Action Being Considered: Minute Order

RECOMMENDATION

Authorize the City Manager or his designee to approve the contract for the removal and replacement of the Lake Arlington buoy system with Consor Engineers, LLC dba U. S. Underwater Services, LLC, of Lakewood, Colorado, in the amount not to exceed \$370,000. Consor Engineers, LLC dba U.S. Underwater Services, LLC, is not a MWBE firm.

ANALYSIS

The contract is for the removal and replacement of the buoy system located at Lake Arlington. The City of Arlington is required by the Texas Commission on Environmental Quality (TCEQ) to have a functioning buoy system at least 200 feet from the raw water pump station intake with visible signage to prevent the public and other entities from potential hazards. The buoy system is critical to Lake Arlington as it provides a barrier to critical infrastructure, along with providing safety to the public. The existing buoy system has broken several times, creating potential safety hazards and is in need of replacement.
