The quarterly investment report has been prepared for the Mayor and City Council as required by Section 2256.023 Internal Management Reports of the Public Funds Investment Act.

The quarterly report includes an investment portfolio summary, and several pages presenting individual investment securities as required by the Act. The report covers all investments of the City and the Venue Debt Reserve. Below are the June 30, 2020 ending values.

The ending book value for the City Total does not include \$19.6mil in collateralized cash balances at the depository bank (JPMorgan). The cash balance provides an earnings credit in lieu of interest and is used to offset bank fees while giving the City a better return than other liquid assets. At this rate, the City yields more value in offsetting bank fees than in interest earnings.

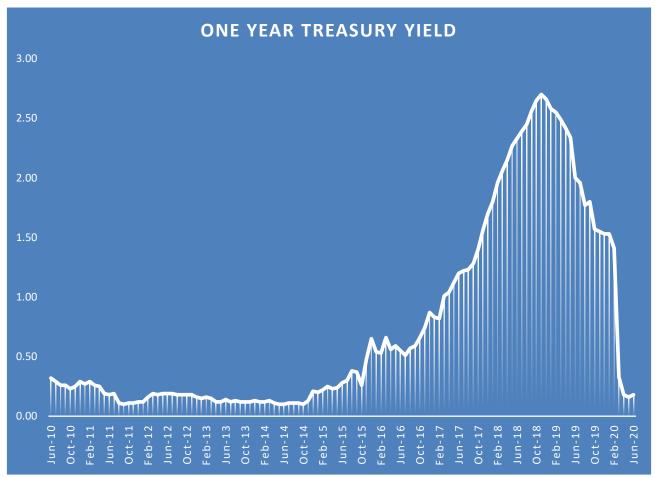
